THIS INDENTURE, made this 17 day of 10 feet, 1973, between Wycliffe. Ltd., a Nebraska limited partnership, hereinafter referred to as "Grantor", and Metropolitan Utilities District of Omaha, a municipal corporation, hereinafter referred to as "Grantee", WITNESSETH:

That Grantor, in consideration of the sum of one Dollar (\$1.00) and other valuable consideration, receipt of which is hereby acknowledged, does hereby grant to Metropolitan Utilities District of Omaha, its successors and assigns, an easement and right of way to lay, maintain, operate, repair, relay and remove, at any time, pipelines for the transmission of gas and water, and all appurtenances thereto, together with the right of ingress and egress to and from the same, on, over, under and through lands described as follows:

Several tracts of land lying in Lots 171, 174, 175, 210, 232, 233, 247, 251, 252, 253, 266, 267, 271, 289 and 290, of Wycliffe Addition, as now platted and recorded, a subdivision in Douglas County, be praska, being more particularly described as follows:

Beginning at the Northeast corner of Lot One Hundred Seventy-one (171), thence South along the East property line of Lot 171 a distance of Thirty (30) feet, thence Northwesterly along a straight line a distance of Forty-two and Forty-three One-hundredths (42.43) feet, more or less, to a point on the North property line of Lot 171, said point being Thirty (30) feet West of the Northeast corner of Lot 171, thence East along the North property line of Lot 171 a distance of Thirty (30) feet to the point of beginning;

A strip of land Seven (7) feet wide running along and parallel to the Westerly property line of Lot Two Hundred Sixty-six (266), said strip being the Westerly Seven (7) feet of Lot 2/6.

A strip of land Seven (7) feet wide running along and parallel to the Easterly property line of Lot Two Hundred Sixty-seven (267), said strip being the Easterly Seven (7) feet of Lot 267;

The West Twenty-eight and Fifty-five One-hundredths (28.55) feet of the East Thirty-five and Fifty-five One-hundredths (35.55) feet of the North Ten (10) feet of Lot Two Hundred Sixty-seven (267);

A strip of land lying in Lot Two Hundred Seventy-one (271), Five (5) feet wide running along and parallel to the Northerly right-of-way line of Douglas Circle, said strip extending from the Southeast corner of Lot 271 West a distance of Eighty-five (85) feet;

A strip of land Seven (7) feet wide running along and parallel to the Easterly property line of Lot Two Hundred Eighty-nine (289), said strip being the Easterly Seven (7) feet of Lot 289;

A strip of land Seven (7) feet wide running along and parallel to the Westerly property line of Lot Two Hundred Ninety (290), said strip being the Westerly Seven (7) feet of Lot 290;

The East Thirty-five and Fifty-five One-hundredths (35.55) feet of the West Forty-two and Fifty-five One-hundredths (42.55) feet of the South Ten (10) feet of Lot Two Hundred Ninety (290);

All these tracts containing a total of Two-tenths (0.2) acre, more or less, all as shown on the plat attached hereto and made a part hereof.

TO HAVE AND TO HOLD said easement and right of way unto the said Grantee, Metropolitan Utilities District of Omaha, its successors and assigns.

- 1. Grantor, its successors or assigns agree that they will at no time erect, construct or place on or below the surface of said tracts of land any building or structure, except pavement, and that they will not give anyone else permission to do so.
- 2. Grantee shall restore the surface of the soil excavated for any purpose hereunder, as near as may be reasonably possible, to the original contour thereof and as soon after such work is performed as may be reasonably possible to do so.
- 3. Nothing herein contained shall be construed as a waiver of any rights of Grantor, or duties and powers of Grantee respecting the ownership, use, operations, extensions and connections to any gas main or water main constructed and maintained hereunder.

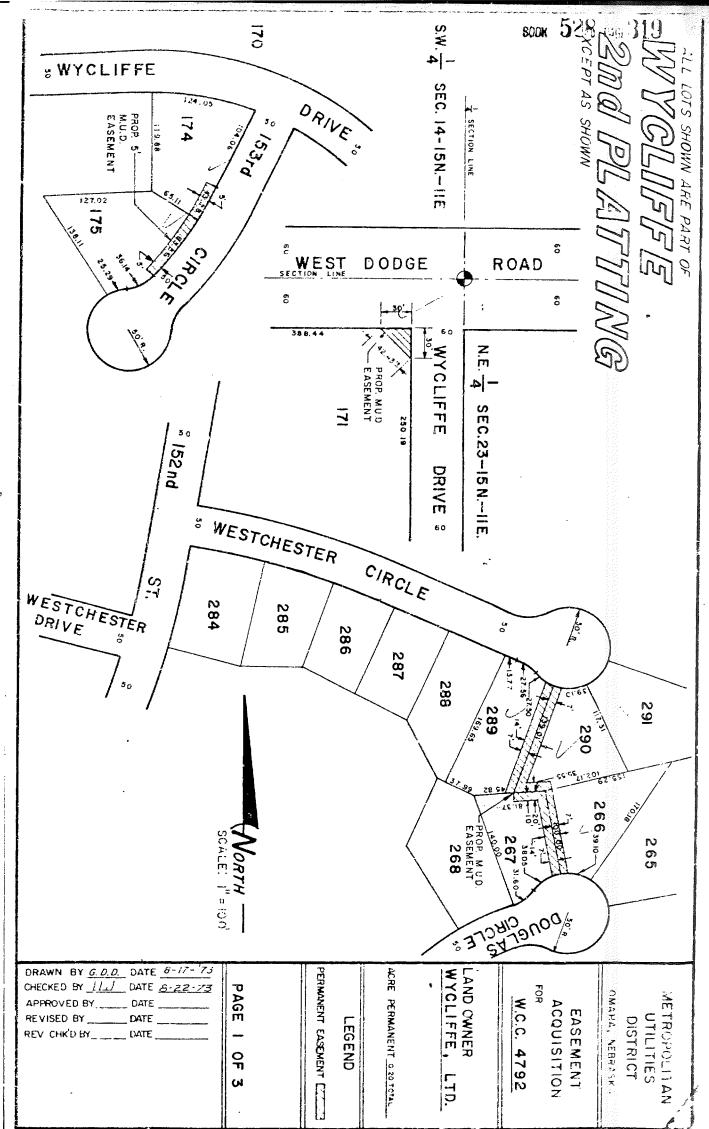

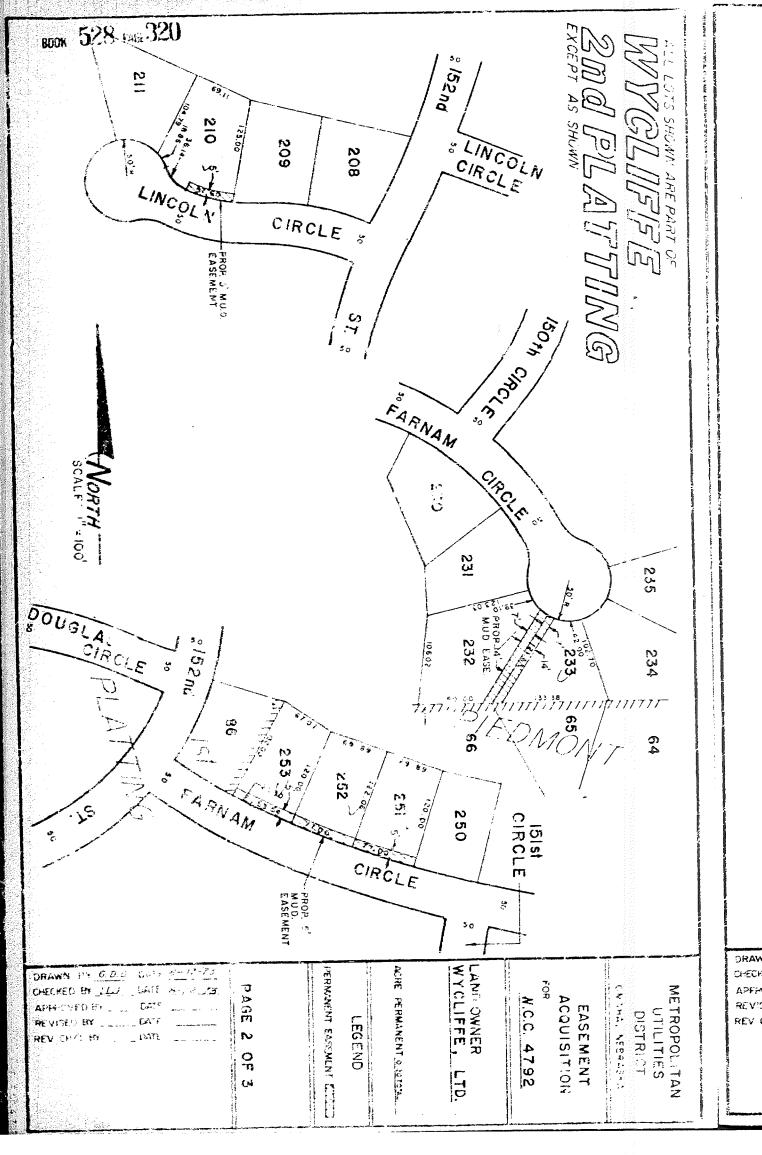
