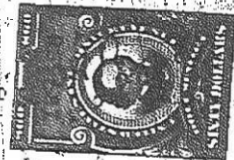

SPECIAL WARRANTY DEED



KNOW ALL MEN BY THESE PRESENTS: That GREAT LAKES PIPE LINE COMPANY, a Delaware corporation, having its principal place of business at 1102 Grand Avenue, Kansas City, in the County of Jackson and State of Missouri, in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, in hand paid by WILLIAMS BROTHERS PIPE LINE COMPANY, a Delaware corporation, having its principal place of business at 1102 Grand Avenue, Kansas City, in the County of Jackson and State of Missouri, does hereby SELL AND CONVEY unto the said WILLIAMS BROTHERS PIPE LINE COMPANY the easements and/or right-of-way grants and agreements listed in Exhibit "A", over, under, upon, across and through lands situated in the County of Pocahontas and State of Iowa described in said Exhibit "A", which said Exhibit "A" is attached hereto and made a part hereof as if fully set forth herein, and all rights of GREAT LAKES PIPE LINE COMPANY under such grants and agreements.

EXCEPTING from this grant those portions of the easements as have been heretofore released, condemned or quit-claimed, all as shown in Exhibit "A"

And it hereby covenants with the said WILLIAMS BROTHERS PIPE LINE COMPANY to WARRANT AND DEFEND the title to said premises against the lawful claims of all persons whomsoever claiming by, through or under it.
