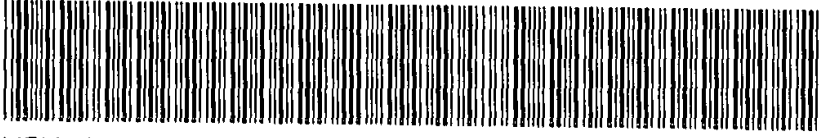

PARTIAL RELEASE OF EASEMENT

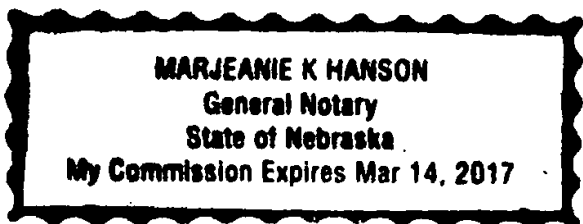
