This Assignment is specifically subject to that certain Agreement dated the 14th day of December, 1979, by and between Assignor and Assignee, and an overriding royalty interest equal to 4.75% of 8/8 in favor of J. Slater, and 1.5% of 8/8 in K. MacNair. The leasehold interest of Assignor and Assignee are to bear the proportionate share of these overriding royalty burdens.
